4. First Aid Measures

Emergency and First Aid

Procedures:

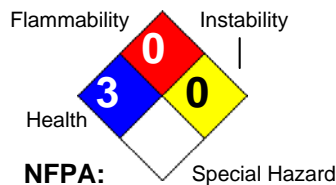
