**Emergency and First Aid**

**Procedures:**

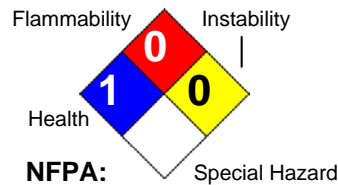
