

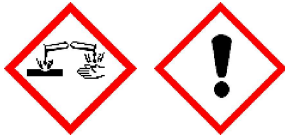

### 4. First Aid Measures

**Emergency and First Aid Procedures:**

- In Case of Inhalation:** Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. If unconscious, call a physician.

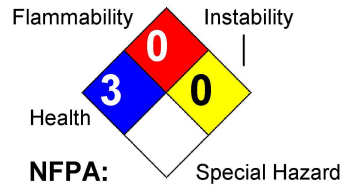
